
Title 13.0501: Election Board Duties Before the Election.

It shall be the responsibility of the Election Board to:

1. Receive and review all notices of intent and determine whether the candidate is qualified for office according to qualifications listed in Chapter 13.07 and determine that such notice is filed by the posted deadline.


Tribal Constitution Article V4b: Eligible candidates shall file their notice of intent to run for office with the Secretary-Treasurer of the Tribal Council, identifying the office for which he is a candidate at least (15) days before the election date. The Secretary-Treasurer shall post a list of eligible candidates at least twelve (12) days before the election in each voting district.

The do herby confirm that all notices of intent have been received and reviewed and that the list above is the official list of eligible candidates, and are listed in ballot order.
